1.2 BIDDER / SUPPLIER must have successfully completed Electrical Substation of 5MW or larger scope on its own directly without formation of Joint Venture or consortium or collaboration (if Joint venture was there then Consultant shall prove to be the lead) (any proposals submitted as Joint Ventures or intention to form Joint Ventures shall be rejected) to Petroleum/ Petrochemical client or Power Plant Operating companies in Kingdom of Bahrain and Middle-east, during the past 10 years.
